Provisional Agenda

To mark the 30th anniversary of the Salamanca Statement that established the fundamental principles of inclusion at school, UNESCO is organizing a high-level policy dialogue on the theme of inclusion in education.

Inclusive policies are imperative to reach Sustainable Development Goal 4 to 'ensure inclusive and equitable quality education and promote lifelong learning opportunities for all'. This means reaching all learners, under the assumption that every learner matters equally. Despite progress, there has not been the transformation in educational systems, nor the policies needed to translate the promise of Sustainable Development Goal 4 into a reality.

The high-level policy dialogue will highlight efforts by governments and partner organizations to advance inclusive educational policies and practices.
